IDRISS MOSQUE / ICW MARRIAGE SERVICES: INFORMATION & APPLICATION FORM (over)

- **Request** for marriage ceremony should be made 2 - 3 weeks **in advance**.
- Couple must provide **all** documents as **required** by city/state law for marriage
- Couple must meet **all** Islamic **requirements** for marriage
- Groom -at minimum- (both bride and groom preferred) shall **meet** with person performing ceremony **prior** to marriage
- **Fee** for services to Idriss Mosque (see marriage request application) **required** and **appreciated**

Parties wishing to get married at Idriss Mosque must acknowledge, by signature and date below, their agreement and understanding of the following requirements **before** completing a marriage request form for services:

1. Marriage **will not** be performed between a Muslim female and a non-Muslim male.
2. A **marriage license** issued by the State of Washington must be obtained and **presented** to the person authorized to perform the marriage, at Idriss Mosque, **prior** to the ceremony.
3. **Approval** of the marriage by the bride's guardian must be demonstrated, **prior** to the marriage
4. A completed, written and **signed agreement** by the bride, groom and the bride's guardian must be presented **prior** to the marriage, for the bride's Dowry (Mahr) gift
5. A **verbalized** commitment to Islamic tenets by the groom and bride must be made, **prior** to the marriage
6. **All** marriages and/ or receptions held at Idriss Mosque **shall conform to Islamic standards**.
7. **Two Muslim males** who know the parties or at minimum know the groom must be present, as **witnesses**, during the ceremony
8. A **'Wakeel** / guardian **for the bride**, regardless of bride's age **must be present**, at and during the marriage ceremony
9. A minimum of \$250 for administrative costs and services shall be made **to Idriss Mosque / ICW**
10. An **appointment** for questions, clarifications, confirmation of compliance with requirements, for services **must be arranged, by the parties**, (call 206-363-3013) no later than **one week prior**, to the ceremony.
