## **MOSQUE CODES of CONDUCT**

**RESPECT YOUR MOSQUE, YOURSELF AND OTHERS**

### **ACTIONS PROHIBITED at IDRIS MOSQUE:**

- ENTRY INTO **MOSQUE** WHEN BUILDING CLOSED
- UNAUTHORIZED PUBLIC MEETINGS and GATHERINGS IN or ON **MOSQUE** PREMISES
- DISRUPTING ACTIVITIES, EVENTS or SERVICES
- DISTURBING THE PEACE
- PHYSICAL or VERBAL ABUSE OF OTHERS
- INCITING DISRUPTIVE OR RIOTOUS BEHAVIOR IN or ON PREMISES
- INTIMIDATING , THREATENING, HARASSING, CRIMINAL ACTS AND/OR BEHAVIORS
- DESTROYING **MOSQUE** PROPERTY
- ILLEGAL PARKING

# ACTIVITIES REQUIRING MOSQUE ADMINISTRATION APPROVAL BEFORE DOING

- CALLING THE ADHAN FOR PRAYER OR LEADING PRAYER
- PERFORMING ISLAMIC COUNSELING, MARRIAGE, DIVORCE, FAMILY SERVICES, ETC.
- SOLICITING, COLLECTING MONIES, POSTING and /or PASSING OUT FLYERS IN/ON MOSQUE PREMISES
- MAKING ANNOUNCEMENTS OR PUBLIC STATEMENTS (USING MICROPHONE OR NOT)
- EDUCATIONAL, SOCIAL ACTIVITIES AND/OR FUNCTIONS; i.e. (bringing/serving food, inviting guest lecturers', holding public gatherings or meetings, Islamic teaching or classes of any kind, inviting groups for MOSQUE visits and/or tours, use of building kitchen, supplies, equipment, etc.

## MOSQUE SERVICES

- ALL REQUEST MUST BE SUBMITTED IN WRITING
- REQUEST FOR FINANCIAL ASSISTANCE MUST BE SUBMITTED ON APPROVED MOSQUE APPLICATION FORM AND BE COMPLETED AS REQUIRED
- REQUESTS FOR MARRIAGE SERVICES REQUIRE PRIOR NOTICE AND WASHINGTON STATE DOCUMENTS IN ACCORDANCE TO LAW - (SEE [WWW.IDRISMOSQUE.COM](http://WWW.IDRISMOSQUE.COM) FOR DETAILS)
